## WORKPLACE HEALTH AND SAFETY – GLENMORE STATE HIGH SCHOOL

Dear Parents/Guardians,

As part of your child's enrolment and learning at Glenmore SHS they will be taking part in a range of different practical learning activities. These practical components have potential risks associated with them.

To align with Education Queensland recommendations and WH&S requirements, parental permission is required for your child to participate in activities that have been designated potentially high or extreme risk.

The following information outlines potential high and extreme risk activities which form part of the learning activities with the Science, ITD, Health and Physical Education and Home Economics Departments at Glenmore SHS.

The relevant safety and operating procedures, techniques and behaviour standards are taught at the beginning of all units and prior to any potentially high or extreme risk activity in order to make all staff and students aware of their safety obligations.

Further safety briefings will be held throughout the year and before students participate in any new practical activities. Participants will be required to formalise their understanding of the WH&S requirements and the behaviour expectations prior to engaging in that activity.
