#### **Notes from Profit and Loss**

- For the month of June Loss of \$ 12 136.57 for the month
  - Same time last year was \$1 492.13 profit
  - Tuckshop sales up by \$ 3 400 compared to same time last year
  - Tuckshop expenses up by \$ 4 800 compared to last year including the purchase of a new display fridge for cold pre orders
  - Uniform shop sales down by \$ 3 170 from last year

- Uniform shop expenses up by \$ 7 600 (new formal uniforms finally came in and majority have been paid for in June)
- Tuckshop P&L for the month of June Loss of \$ 5 492
  - Income \$ 23 592
  - Less expenses \$ 20 308
  - Less payroll \$ 8 777 (this amount includes uniform shop hours)

FYI: Tuckshop income for 6 months of 2023 is \$ 142 525 already. (An increase of \$ 29 106)

- Profit for Year to Date: \$ 21 932
- Student Council have a balance of \$1 103.12 remaining (income less the expenses that P&C are holding for them)
- P&C are also holding \$500 for the Indigenous Dance Troupe donation came from Park Ave SS for them.
